**PROPOSITION SR3 MAINTENANCE**

Shall the Board of Education of the Savannah R-III School District, Missouri, be authorized to increase the operating tax levy of the District by \$0.1500 TO \$3.9117 per one hundred dollars of assessed valuation through Tax Year 2031 in order to provide funds for the completion of ongoing District repairs and maintenance projects?

If this proposition is approved, the adjusted operating levy of the District is estimated to increase by \$0.1500 from \$3.7617, currently, to \$3.9117 per one hundred dollars of assessed valuation for Tax Year 2022 and can be applied to the assessed valuation for each year thereafter though Tax Year 2031.
