SUTTON of the Western District Court of Appeals be retained in office?</p> <p><input type="radio"/> YES</p> <p><input type="radio"/> NO</p>	<p>CONSTITUTIONAL AMENDMENT NO. 5</p> <p><i>Proposed by Initiative Petition</i></p> <p>Do you want to amend the Missouri Constitution to:</p> <ul style="list-style-type: none"> • allow the Missouri Gaming Commission to issue one additional gambling boat license to operate on the portion of the Osage River from the Missouri River to the Bagnell Dam; • require the prescribed location shall include artificial spaces that contain water and are within 500 feet of the 100-year base flood elevation as established by the Federal Emergency Management Agency; and • require all state revenues derived from the issuance of the gambling boat license shall be appropriated to early-childhood literacy programs in public institutions of elementary education? <p>State governmental entities estimate one-time costs of \$763,000, ongoing costs of \$2.2 million annually, initial fee revenue of \$271,000, ongoing admission and other fee revenue of \$2.1 million annually, and annual gaming tax revenue of \$14.3 million. Local governments estimate unknown revenue.</p> <p><input type="radio"/> YES</p> <p><input type="radio"/> NO</p>	<p>PROPOSITION A</p> <p><i>Proposed by Initiative Petition</i></p> <p>Do you want to amend Missouri law to:</p> <ul style="list-style-type: none"> • increase minimum wage January 1, 2025 to \$13.75 per hour, increasing \$.25 per hour each year until 2026, when the minimum wage would be \$15.00 per hour; • adjust minimum wage based on changes in the Consumer Price Index each January beginning in 2027; • require all employers to provide one hour of paid sick leave for every thirty hours worked; • allow the Department of Labor and Industrial Relations to provide oversight and enforcement; and • exempt governmental entities, political subdivisions, school districts and education institutions? <p>State governmental entities estimate one-time costs ranging from \$0 to \$53,000, and ongoing costs ranging from \$0 to at least \$256,000 per year by 2027. WITT of the Western District Court of Appeals be retained in office?</p> <p><input type="radio"/> YES</p> <p><input type="radio"/> NO</p> <p>CONSTITUTIONAL AMENDMENT NO. 2</p>	<p><i>Proposed by Initiative Petition</i></p> <p>Do you want to amend the Missouri Constitution to:</p> <ul style="list-style-type: none"> • allow the Missouri Gaming Commission to regulate licensed sports wagering including online sports betting, gambling boats, professional sports betting districts and mobile licenses to sports betting operators; • restrict sports betting to individuals physically located in the state and over the age of 21; • allow license fees prescribed by the Commission and a 10% wagering tax on revenues received to be appropriated for education after expenses incurred by the Commission and required funding of the Compulsive Gambling Prevention Fund; and • allow for the general assembly to enact laws consistent with this amendment? <p>State governmental entities estimate one-time costs of \$660,000, ongoing annual costs of at least \$5.2 million, and initial license fee revenue of \$11.75 million. Because the proposal allows for deductions against sports gaming revenues, they estimate unknown tax revenue ranging from \$0 to \$28.9 million annually.
